



- 8 The funds required to fulfil the purposes of the Association shall be raised by collecting subscription from members and donations from the public or member
- 9 The Association shall consist of three classes of members:
 - a. Patrons those who pay Rs. 1000/-
 - b. Life Members those who pay Rs.500/- and
 - c. Ordinary Members/Yearly membership those who pay Rs. 100/- annually.
- 10 The Financial year of the Association shall commerce from the $1^{\rm st}$ April and ends on 31th March.
- 11 The affairs of the Association shall be managed by an Executive Committee of 16 Members elected from among the members of the Association. The Executive Committee shall consist of a President, Vice-President, Two Secretary and a Joint Secretary and then other members.
